Sub: Information of beaten by many persons to a child named Gagan Behera, who has been deinstitutionalized without providing any rehabilitation schemes just after 2-3 days of his admission to a CCI named "Nayagarah Kala Parisada"

Respected Sir/Madam,

With due respect we want to inform you about an incident happened on date 5 December 2020 at Magarabandha, Nayagarah. The child named Gagan Behera has been beaten by many persons of this village with binding his hands with a suspicion that Gagan had stolen something from a house. Then Gagn Behera had been bounded at a tree with a rope for hours. Then on the next day Gagan with his mother had come to us at Bhubaneswar with fear and we had taken him to Capital Hospital for his treatment and we had got the medical reports of this incident from the medical on that day. But till now, the situation is not normal. For your information, Gagan Behera is the same child who had been admitted to a CCI named Nayagarah Kala Parisada on 12.10.2020 and after few days Gagan Behera has taken to his own village by Pravasini Madam of the CCI due to any reason and Gagan's mother had been forced to sign on a paper by Pravasini Madam. Although Gagan's mother had not signed on any paper, but still Gagn Behera had been deinstitutionalized without providing any schemes to him. Regarding this misconduct of the CCI, Gagan's mother and we had also given you the written complain. But now to secure Gagn's child hood you should take any immediate measures for him. We are attaching the following documents with this applications.
